What is GDPR?

The European Data Protection Regulation, which replaces the one in force in Poland the act and unifies the regulations on the processing of personal data in the European Union. The regulations in force so far were created before the development of new technologies, geolocation,

social media, profiling or data storage in the cloud.

On what basis are personal data processed?

Personal data is processed on the basis of:

- the need to complete your order;
- legitimate interest, eg answering a complaint, goals marketing;
- due to the need to fulfill a legal obligation, for example: issuing and storage of invoices, accounting documents (tax and fiscal obligations);
- your consent voluntarily.

On what occasions do we collect your data?

We may obtain data from you, e.g. in the following cases: by concluding contracts, starting cooperation, setting up system access accounts, purchasing processes, granting responding to complaints, participating in training or expressing willingness to receive newsletters, registration at fairs.

How long is the data stored?

Personal data is stored for the time required to complete the order or provision of the service, required by legal regulations, e.g. tax, penal and fiscal regulations or to the time you withdraw your consent in case of consent to receive the information marketing.

What are your rights in relation to the processing of personal data? Persons whose data is processed have the following rights:

• the right to object to data processing

It can be brought in when we process the data on our legitimate grounds an interest with which you do not agree. If the objection turns out to be justified, the data will remain

deleted.

• the right to rectify (correct) data

This right may be exercised if the processed data is incorrect or incomplete.

• the right to delete data (to be forgotten)

You may request the deletion of your personal data in the following situations:

- when the consent on the basis of which personal data was processed has been withdrawn;
- when the data is not necessary for the purposes for which it was collected;
- an objection to data processing has been raised
- when personal data are processed unlawfully.
- the right to restriction of processing

You can request that we do not process certain personal data (except for their storage), but not completely delete them.

• the right to access data

The law allows you to obtain information whether the Administrator processes personal data, what the data is processed for what purpose and at what time and to obtain a copy of your data personal.

• the right to data portability

You can submit a request to prepare the data that is in the possession of the Administrator in in a structured form, in a commonly machine-readable format and / or ask for their transfer to another Data Administrator.

How can I manage my data or withdraw my consent to the processing of my data? You can change your consent regarding the methods of communicating with you at any time, rectify data or withdraw consent to their processing using the register, available at at: biuro@cermotor.com.pl
